6. Submit the application electronically through the portal.

- ii. Hard copy submissions shall not be accepted.
- iii. A non-refundable application fee of Ksh. 3,000 shall be payable for each application
- iv. Suppliers may apply for multiple categories provided they meet the requirements for each category.
- v. Registration in the supplier database shall not constitute a guarantee of award of any contract.
- vi. The University reserves the right to accept or reject any application and is not bound to give reasons for its decision.
